Notice is hereby given that in pursuance of a Resolution of the Board of Trustees of Austintown Township, Mahoning County, Ohio, passed on the 4th day of May, 2023, there will be submitted to a vote of the people at the General Election to be held at the regular places of voting on Tuesday, the 7th day of November, 2023 the question of levying a tax, in excess of the ten mill limitation, for the benefit of the Austintown Township for the purpose of providing and maintaining fire apparatus, mechanical resuscitators, underwater rescue and recovery equipment, or other fire equipment and appliances, buildings and sites therefor, or sources of water supply and materials therefor, for the establishment and maintenance of lines of fire-alarm communications, for the payment of firefighting companies or permanent, part-time, or volunteer firefighting, emergency medical service, administrative, or communications personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.34 of the Revised Code, for the purchase of ambulance equipment, for the provision of ambulance, paramedic, or other emergency medical services operated by a fire department or firefighting company or the payment of other related costs.
