

**PROCLAMATION
NOTICE OF GENERAL ELECTION**

The Board of Elections of Mahoning County, Ohio, issues this Proclamation and Notice of Election.

A **General Election** will be held on **Tuesday, the 7th day of November, 2023**, at the usual place of holding elections in each and every precinct throughout the County or at such places as the Board may designate, for the purpose of choosing the following offices:

Youngstown; Judge of the Municipal Court, Clerk of the Municipal Court and Ward Council Members. Campbell; Judge of the Municipal Court, Mayor, Council president, Ward Council Members and Director of Law. Struthers; Judge of the Municipal Court, Mayor, President of Council, Auditor, Director of Law, Council at Large and Ward Council. Township Trustees and Township Fiscal Officers, Village Mayor's, Members of Council and Beloit Board of Public Affairs, Mahoning County Educational Service Center and members of all School Boards in Mahoning County.
